A regular meeting of the Cambridge City Council was held on July 10, 2023, at Cambridge City Hall. Present were Mayor Mark Loveland, Council President Gene Neumann, Councilmember Delray Platt, Councilmember Levi Harrison and Councilmember Nanette Rhodes. Also, present were Sandra McKee City Clerk/Treasurer, Corey Morgan Public Works Superintendent, Robert Almanzo of HECO Engineers, Pat Britzius of The Record~Reporter, Travis Williams of Hardin Sanitation, Nina Hawkins, and Thel Pearson.

REGULAR MEETING

<u>Welcome and Pledge of Allegiance</u> – Mayor Mark Loveland called the meeting to order at 7:00 p.m. and welcomed patrons to the meeting. Nan Rhodes led the Pledge of Allegiance.

<u>Consent Agenda – ACTION ITEM</u> – Gene Neumann made a motion to approve the consent agenda (approve current agenda, approve Regular Meeting Minutes June 12, 2023, and pay bills). Nannette Rhodes seconded the motion and the motion passed unanimously.

<u>Hardin Sanitation Rate Increase Request – Travis Williams – ACTION ITEM</u> – Travis Williams the Site Manager for Hardin Sanitation requested the council approve a proposed Solid Waste Rate Adjustment CPI (8) from Hardin Sanitation. The request is for an 8% price increase for both Commercial and Residential service effective August 1, 2023. The proposed adjustment would get the pricing in Cambridge in line with the rest of Hardin's' adjoining jurisdictions. This adjustment equates to an additional \$1.68 per month for the most frequently utilized service level. Delray Platt made a motion to approve Hardin Sanitation Rate Increase Request. Gene Neumann seconded the motion and the motion passed unanimously.

<u>Property at the End of 1st Street – Kermit Wiggins</u> – This item not needed as per Kermit Wiggins

HECO Engineers Report - Transportation, Streets, Roads, Water System and Wastewater System – Robert Almanzo of HECO Engineering reported HECO submitted US 95 Pedestrian Improvements Draft Plans, Specifications and Cost Estimate for the City review and comment on June 29, 2023. HECO submitted the Draft Wastewater Facility Plan for City review and comment on July 6, 2023.

<u>Child Pedestrian Safety Hwy 95 Pedestrian Improvements Project Design HECO Engineers– ACTION ITEM</u> – After review Nanette Rhodes made a motion seconded by Delray Platt to approve the Child Pedestrian Safety Hwy 95 Pedestrian Improvements Project Design by HECO Engineers. Delray Platt seconded the motion. The motion was voted on with Councilmember Neumann aye, Councilmember Nanette Rhodes aye, Councilmember Delray Platt aye, and Councilmember Levi Harrison nay. The motion passed.

<u>Approve Tentative Budget for 2023-2024 FY2024 – ACTION ITEM</u> – After review of the tentative budget with City Clerk Sandra McKee, Nanette Rhodes made a motion to approve the Tentative Budget for 2023-2024 FY2024. Levi Harrison seconded the motion and the motion passed unanimously.

<u>Draft Ordinance No. 2-2023 Accessory Dwelling Units – ACTION ITEM</u> – The council reviewed the updated draft ordinance and like the changes that were made from the previous meeting. Delray Platt made a motion seconded by Nanette Rhodes to set another Public Hearing on Accessory Dwelling Units on August 14th at 7:15 or immediately following the budget hearing at 7:00 p.m. The motion was voted on and passed unanimously.

Ordinance No. 3-2023 Dog Kennels— ACTION ITEM — Nannette Rhodes made a motion to introduce and read Ordinance #3-2023 Dog Kennel by title only under suspension of rules and regulations. The motion was seconded by Gene Neumann. City Clerk Sandra McKee took a roll call vote with Councilmember Neumann aye, Councilmember Harrison aye, Councilmember Rhodes aye, and Councilmember Platt aye. The motion passed unanimously. Nanette Rhodes then read Ordinance #3-2023 by title only. Nanette Rhodes made a motion to suspend the rules and regulations and waive the 2md and 3rd readings and vote on Ordinance #3-2023. Gene Neuman seconded the motion. The City Clerk took a roll call vote with Councilmember Neumann aye, Councilmember Harrison aye, Councilmember Rhodes aye, and Councilmember Platt aye. The motion passed unanimously. Nanette Rhodes made a motion to pass Ordinance #3-2023 under suspension of rules and regulations on one reading by title only. The motion was seconded by Levi Harrison. A roll call vote was taken with Councilmember Neumann aye, Councilmember Harrison aye, Councilmember Nanette Rhodes aye, and Councilmember Platt aye. The motion passed unanimously.
