

***City of Cambridge
Special Meeting
August 24, 2020
7:00 p.m.***

A special meeting of the Cambridge City Council was held on August 24, 2020 at Cambridge City Hall in person and by telecommunication devices. The purpose of this special meeting was to consider approval of the Transportation Capital Improvement Plan, Future Projects, Street Ratings Inventory, and Schedule a Public Hearing for Approval of the Updated City of Cambridge Transportation Plan. Also, to approve Ordinance #1-2021 – Annual Appropriations Ordinance.

Present were Mayor Jack Toothman, Councilmember Delray Platt, Councilmember Levi Harrison, and Councilmember Mark Loveland. Also present were City Clerk/Treasurer Sandra McKee and Public Works Superintendent Corey Morgan. Council President Jeff Chance was absent. Robert Almanzo of HECO Engineers called in by telecommunication device. The connection to the meeting was not restricted.

Mayor Toothman called the meeting to order at 7:03 p.m. The mayor explained that the purpose of this special meeting was to consider approval of the Transportation Capital Improvement Plan, Future Projects, Street Ratings Inventory, and Schedule a Public Hearing for Approval of the Updated City of Cambridge Transportation Plan. Also, to approve Ordinance #1-2021 – Annual Appropriations Ordinance. Mayor Toothman welcomed everyone to the meeting and Delray Platt led the Pledge of Allegiance.

Approval of the Transportation Capital Improvement Plan, Future Projects, Street Ratings Inventory, and Schedule a Public Hearing for Approval of the Updated City of Cambridge Transportation Plan – ACTION ITEM – Discussion was held on these items. Mark Loveland made a motion to approve the Transportation Capital Improvement Plan, Future Projects, Street Ratings Inventory, and Schedule a Public Hearing for September 14th, 2020 at 7:00 p.m. at Cambridge City Hall for Approval of the Updated City of Cambridge Transportation Plan. Levi Harrison seconded the motion and the motion passed unanimously.

Approve Ordinance #1-2021 – Annual Appropriations Ordinance – ACTION ITEM – Levi Harrison made a motion to introduce and read Ordinance #1-2020 Annual Appropriations Ordinance by title only under suspension of rules and regulations. The motion was seconded by Mark Loveland. City Clerk Sandra McKee took a roll call vote with Councilmember Harrison aye, Councilmember Loveland aye, and Councilmember Platt aye. The motion passed unanimously. Levi Harrison read Ordinance #1-2021 by title only. Levi Harrison then made a motion to suspend the rules and regulations and waive the 2nd and 3rd readings and vote on Ordinance #1-2021. Mark Loveland seconded the motion. The clerk took a roll call vote with Councilmember Harrison aye, Councilmember Loveland aye, and Councilmember Platt aye. The motion passed unanimously. Levi Harrison made a motion to pass Ordinance #1-2021 under suspension

of rules and regulation on one reading by title only. The motion was seconded by Delray Platt. A roll call vote was taken with Councilmember Harrison aye, Councilmember Loveland aye, and Councilmember Platt aye. The motion and ordinance passed unanimously.

Levi Harrison made a motion to adjourn and Mark Loveland seconded the motion and the meeting adjourned at 7:22 p.m.
